





What is NCLEX-RN ?

NCLEX (National Council Licensure Examination) is a nationwide examination for the licensing of nurses in the United States and Canada since 1982 and 2015, respectively.

NCLEX exam are delivered electronically. The number of questions that need to be answered varies per student, as they are generated based on the answers of your previous question. As such, you might have to answer anything between 75 and 265 questions.

CGFNS verifies applicants' foreign academic and professional credentials and delivers a report to the New York State Education Department, which then evaluates the credentials.

2. VisaScreen

VisaScreen® : Visa Credentials Assessment Service is a comprehensive screening service for healthcare professionals seeking an occupational visa to work in the United States. Applicants who successfully complete VisaScreen® receive an official ICHP Certificate for the VisaScreen® : Visa Credentials Assessment Service. This certificate satisfies the United States Federal screening requirements and it is a mandatory submission to receive an immigrant visa.

3. Credentials Evaluation Service Academic Report®

The Credentials Evaluation Service (CES) Academic Report® provides a detailed analysis of all nursing education received outside the United States. It is advisory in nature and does not make specific placement recommendations. Nurses use the CES Academic Report® for academic admissions purposes. The CES Academic Report® includes a detailed analysis of the courses you attended along with suggested U.S. grade and credit conversions.
